ORDER

WHEREAS, in exercise of tire powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act; 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- AND WHEREAS, the institution ,Mahatma Gandhi University College of Teacher Education, Kudamaloor, Kothayam - \$86017, Kerala has by affidavit consented to come under New Regulations and sought for one basic unit in B.Ed.
- AND WHEREAS, on scrutiny it is found that a notice was issued to the institution on 32.07.2009 to submit the documents pertaining to shifting of premises. The revised order is issued subject to the decision of SRC on the reply to be submitted by the institution
- 4 AND WHEREAS, it has been decided to permit the institution to have one basic unit of 50 students subject to the institution fulfilling following conditions namely,
 - The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31st July, 2015 failing which recognition will be withdrawn.
 - The Regional Committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution does not fulfil required norms of infrastructure recognition will be withdrawn.
- NOW THEREFORE, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Mahatma Gandhi University College of Teacher Education, Kudamaloor, Kottayam - 686017, Kerala for conducting B.Ed programme of two years duration with an annual intake of 50 students(one basic unit) from the academic session 2015-16
- Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGD, affiliating University/Body, the Stale Government etc. as applicable
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annua, accounts duly audited by a Chartered Accountant.
